### **Craft Bursary Scheme Terms and Conditions:-**

- 1 Only one application is permitted per student.
- 2 The minimum age for applicants is 16 years old.
- 3 The maximum age for applicants is the State Pension Age prevailing at the time of application.
- 4 The course subject being studied must be directly related to the Company's three crafts, namely bricklaying, roof slating and tiling and wall and floor tiling.
- 5 The applicant agrees to promote and interact positively with the Worshipful Company of Tylers and Bricklayers.
- 6 The Company undertakes to provide a dedicated Mentor from within its membership who will help support and guide the student through their training.
- 7 The applicant undertakes to interact with their Mentor, provided by the Company, and provide regular updates on their progress to the Mentor.
- 8 The Company will invite successful applicants to attend the Company's annual Craft Awards Lunch, held in London, usually in March, the first year after the award of the Bursary.
- 9 Each bursary award is £1,000 and will be paid to the successful applicants bank account on or before 30 September 2024.
- 10 The applicant undertakes to complete his or her training course. If a successful applicant fails to complete the training course, the Company may in its discretion and after reviewing all relevant circumstances, require the successful applicant to repay the Bursary.
- 11 The Company reserves the right to require the successful applicant to repay the Bursary if he/she fails to comply with the terms and conditions of the Scheme after the award of the Bursary. For example, failure to engage with the mentor or behaving in a way that damages the reputation of the Company.
- 12 The scheme is open to applications from 1 April 2024.
- 13 The scheme closes to applications on 30 June 2024.
- 14 Applications received after the closing date will not be considered.
- 15 Applications will be vetted during July and August.
- 16 Applicants agree that the Company may contact the named referee(s) and/or the training provider in relation to the application for a Craft Bursary and/or to seek confirmation of the granting of a place on a recognised training course. Applicants acknowledge and agree that all communication between the Company, the referee(s) and the course provider will be confidential. Failure to provide a satisfactory reference may result in the application being rejected.
- 17 During the vetting process and in order for the application to be considered further, the applicant must attend an interview with the nominated Trade Mentor. This interview will be carried out remotely via Zoom or other video conferencing medium. During this interview the Mentor will discuss all aspects of the application. If the applicant fails to attend this interview or provides inadequate answers to any questions it will result in their application being rejected and not considered any further.
- 18 Successful applicants will be notified by email on or before 30 September 2024.
- 19 Unsuccessful applicants will be notified by email on or before 30 September 2024.
- 20 The decision of the Worshipful Company of Tylers and Bricklayers is final and there is no right to appeal. No reasons or other feedback will be given by the Company and the Company will not enter into any correspondence about the outcome of any application for a Craft Bursary.
